2. Faxed copies of supplemental application documents (DD-214, transcripts, etc.). Please remember to fax all supporting documentation using the Auto-Requested Fax feature described in the REQUIRED DOCUMENTS section of the vacancy announcement. Copies of the applicable documents must be submitted for each vacancy that you apply for.
