After some discussion, proposed activities for 1990 were outlined as follows:

- 1. Seek co-sponsorship with Izaak Walton League of America, Inc. of meeting in Reno on Dec. 12-14, 1990, entitled "Riparian Confluence ... Full Stream Ahead". Meeting will feature presentations from a variety of publics throughout the West regarding improved riparian management. Emphasis will be on rebuilding watersheds, cooperation, and where the success stories are.
- 2. Explore the development of educational materials that include elementary and secondary school levels as well as general lay audiences. The materials would focus on how streams function and their general importance and the verbiage and illustrative materials would be simple and easily understood.
- 3. Join with the Public Affairs Committee in writing to the EPA regarding grants to States in implement nonpoint source (NPS) management programs under section 319 of the Clean Water Act. The letter would stress some needed changes in how the \$40 million grant fund is administered.
- 4. Possibly seek to hold another symposium at the next SRM annual meeting in Washington, D.C.
- 5. Continue to serve in a review capacity for the SRM on matters related to riparian management.

## Comments

- 1. The <u>Riparian Symposium</u> held on Wednesday, February 14, was a huge success. Several hundred people attended. A good exchange followed the presentations by Johanna Wald, Steve Johnson, Rose Strickland, Jane Leeson, and Sherm Swanson.
- 2. The <u>Riparian Resources in Arid Lands</u> technical session held in New Orleans on February 19 had a much smaller turnout, but the papers were excellent. Discussion followed the presentations, and Ms. Kathryn R. Tollerton, Associate Conservation Director for Government Relations for Defenders of Wildlife, was an active participant in the discussions.
