

# SRM Outstanding Achievement: Commitment to Community Engagement Award

### **Purpose**

The SRM Commitment to Community Engagement Award is awarded to an individual or group who actively promotes and enhances diversity and inclusion in the rangeland profession and across communities. The recipient contributes to and advances the mission and vision of SRM through sustained efforts to engage and improve opportunities for the broad communities who care for rangelands.

One Award may be given per year at the SRM Annual Conference, where the recipient will receive an honorary plaque.

## **Award Eligibility, Submission & Evaluation**

This award is open to individuals or groups who are actively involved in the rangeland profession or community. **Nominees DO NOT need to be current members of SRM to be eligible.** Nominees will be evaluated according to the criteria below. Please send your nomination form via email to SRM Headquarters (office@rangelands.org) by June 1st.

#### **Award Criteria**

The SRM Commitment to Community Engagement Award is awarded to an individual or group who actively promotes and enhances diversity and inclusion in the rangeland profession and across communities. The recipient contributes to and advances the mission and vision of SRM through sustained efforts to engage and improve opportunities for the broad communities who care for rangelands, with cumulative achievements having a direct and significant impact. We highlight four broad criteria below (bullet points) with examples of evidence related to each, however, this list is not exhaustive.

- Contributions to recruitment and mentorship of diverse SRM members, ranchers, rangeland professionals, management technicians, and/or pre-professionals from a breadth of different backgrounds.
  - Ex. 1: Supports a broad pool of mentees in SRM or the broader rangeland community
  - Ex. 2: Receives exceptional evaluations from a broad range of mentees who have directly benefited from the nominee's teaching/mentoring
  - Ex. 3: Evidence of professional success among mentees in the rangeland profession
- Supports innovative rangeland activities and program development focused on engagement, recruitment, and retention of underrepresented communities.
  - Ex. 1: Develops effective training programs for rangeland professionals from all backgrounds
  - Ex. 2: Leads education camps or workshops that serve underrepresented views and communities
  - Ex. 3: Serves with, or leads, organizational groups dedicated to the advancement of diversity and inclusion in rangeland management (external to SRM)
- Advances diversity and inclusion through research, scholarship, and/or outreach efforts centered on rangelands.
  - Ex. 1: Publishes articles and reports to SRM affiliate journals or other outlets related to the inclusion of varied perspectives on the study, conservation, and management of the world's rangelands.

- Ex. 2: Creates media to be shared through various outlets focusing on diversity and inclusion, or spotlighting the broad range of voices and contributions within the rangeland community
- Ex 3: Shares resources and information on these topics through presentations and/or outreach events
- Creates a culture of inclusion in rangeland communities.
  - Ex 1: Creates or promotes environments for the sharing of different perspectives among members of rangeland communities, for example, through SRM Campfire Sessions, or international or multi-disciplinary collaborations
  - Ex 2: Supports community-building and collaboration in rangeland communities through informal mechanisms (e.g., welcoming community gatherings, personal invitations for individuals with different perspectives, effective 'open door' policies)
